



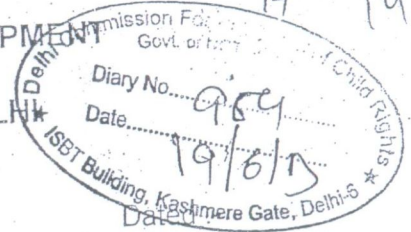

Apropos notification no. F. No. 61(425)/DCPCR/CP/CPU/DWCD/2012/9752-779 dated 29.06.2012. It stated that Sh.
