Delhi Commission For Protection of Child Rights (DCPCR) is organising 2-days capacity building-cum-raining programme for Child Welfare Committees (CWC), Juvenile Justice Boards (JJB) and District Child Protection Officers (DCPO) on 5th-6th August 2021.

The training also has components of robust management of Children Homes and rehabilitative measures for children in vulnerable situation.
